# Membership Information

## EQUITY MEMBERSHIP

An EQUITY MEMBERSHIP at Lynx Ridge Golf Club offers the best of both worlds. Members receive all the privileges and benefits of a first class country club while maintaining the right to sell the membership in the future and retain 80% of the proceeds from the sale.

### What Is An Equity Membership?

Equity means ownership of a saleable asset. Your membership at Lynx Ridge is a saleable asset. When your membership is sold under the conditions as outlined in the by-laws, the retiring member determines the sale price and receives the proceeds from the sale (less a 20% redemption fee).

### Admission Of A Member

A person or corporation may, by submitting an application for membership in writing to the Club, together with payment of the initial membership fee, become a member of the golf club. There is only a maximum of 190 additional equity memberships available at Lynx Ridge.

## MEMBERSHIP CATEGORIES

### Principal Members

A Principal Member is the owner of a membership or the Corporate Designee for a corporation, which owns a membership. Principal Members may sponsor their spouse or children as Associate Members. The Principal Member also has the voting rights in the Society and may serve on the Board of Directors for the members. Upon paying annual dues a Principal Member enjoys all the rights and privileges offered. See “Member Privileges” Each year a principal member has the option to forgo their weekend playing rights (will still be eligible to participate in weekend member tournaments); if this option is chosen then a 10% discount will be reflected on their annual dues.

### Associate Members

Both Principal Members and Corporate Designees may sponsor their spouse and children or all or any of them, in each case, as an Associate Member of the Club on a year by year basis. Each child of a member must be younger than 29 years of age throughout the year in order to qualify as an Associate Member.

The annual dues for the Principal Members are payable each season by January 31st. Associate dues are optional and payable upon joining the club for the season.

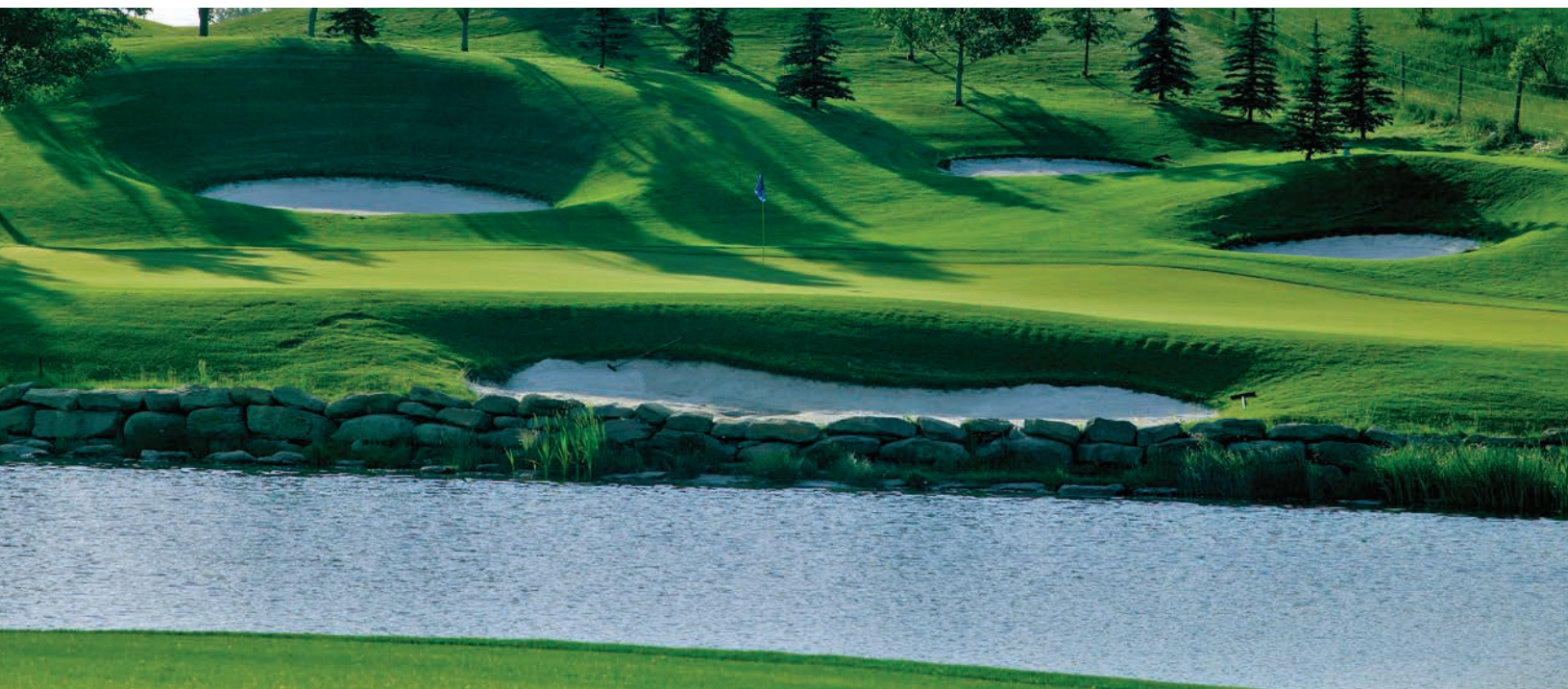

## RESTRICTED PLAY

Reduced dues are offered to Associate Members based on restricted playing privileges. Restricted hours for Restricted Spouses, Intermediates, Juniors and Juveniles are Weekdays from 4 to 6 p.m. and prior to noon on weekends and holidays. Restricted hours are subject to change depending upon the needs of the membership.

## **GOLF COURSE & CLUBHOUSE FACILITIES**

The centerpiece of Lynx Ridge Golf Club is the golf course itself. Lynx Ridge Golf Club has been masterfully designed to be both challenging and fair to all levels of golfers. With 5 sets of tees on each hole and playing between 5,180 and 6,826 yards, par 71, each golfer can choose the length and level of difficulty that best suits their game. Our well manicured and pristine golf course takes full advantage of the varied terrain while our numerous ponds and white silica sand bunkers add beauty and challenge to the overall layout. Future plans include lengthening of the golf course to reach 7100 yards from the championship tees, a revised par of 72, the addition of several water features including streams and ponds and the planting of upwards of 600 new trees.

Our extensive practice facilities include a spacious 300-yard driving range, 2 large practice putting greens, a practice sand trap and a private, covered lesson area. The driving range and putting greens are conveniently located just outside of the pro shop and are the ideal place to work on your game and chat with fellow members. Unlimited use of the driving range and practice facilities is included with the membership.

Membership at Lynx Ridge Golf Club also provides use of all of the indoor facilities, which include the beautiful clubhouse with complimentary locker rooms and club storage for our members. The clubhouse also features a licensed lounge, restaurant and deck with spectacular views of the Bow River Valley, downtown Calgary and the Rocky Mountains beyond. Members are also invited to utilize our spacious clubhouse and banquet facilities for year round activities such as meetings, weddings and Christmas parties. Plans are also in the works for major expansions to the clubhouse to further make our facility a fully functional, year round member club.

## **CLUB ACTIVITIES AND TOURNAMENTS**

Member committees organize several competitive member tournaments as well as several fun, social activities for fellow members at Lynx Ridge Golf Club. Club tournaments include such events as the Opening and Closing events, Member Guest, Club Championship and Ironman. Our members also participate in interclub events around Southern Alberta such as the Soup Bowl, the Battle of The Bow, Men's, Ladies, Senior and Junior Interclub and the International Pairs competition. Other special events and activities may include mystery tours, member socials, dances, golf clinics, Christmas/New Year's Eve parties, fishing derbies, etc. etc. Members may participate as much or as little as they please.

## **DRESS REGULATIONS**

All members and their guests are required to wear suitable golf attire at all times while on the golf course or practice facilities. Contemporary golf attire changes from time to time therefore the acceptability of any particular apparel will be reviewed regularly by management and occasional changes may occur. Those offending the dress code will be asked to change into suitable attire or leave the premises.



## **GUESTS**

Members may invite up to 3 guests/day to play at anytime during the week (Monday – Friday). For weekend play, Principal and unrestricted Spousal members may bring 1 guest each for tee times prior to noon, and 3 guests each for tee times after noon. Guest booking rules may be subject to change based on member tee time demand.

## **COMPUTERIZED HANDICAPS**

The golf club provides a computerized handicapping system in the member's locker room which allows all members to calculate an official RCGA handicap index. After a round is completed, members should enter their scores directly into the computer. This promotes fair competition and accurate and friendly games and matches. Members who fail to properly maintain an Official RCGA index will not be eligible for club golf events and league activities. Our members have access to free rules of golf clinics to further understand the game, handicaps and the benefit of maintaining and accurate and official RCGA index.

## **GOLF RULES AND CLUB REGULATIONS**

The management of the golf club will establish the golf course rules. The Board of Directors will be a liaison between the members and the management and will be an integral part of establishing and enforcing the rules. If any member has a concern, complaint or suggestion, they should direct these items, in writing, to the management or to the Board of Directors.

## **NO MANDATORY F & B CHARGES**

There are no pro shop or restaurant mandatory spending requirements at Lynx Ridge. We want to earn your business. Principal Members and their Associates have the option of charging or paying cash for golf equipment, food and beverages and other services at the golf course. Principal Members are responsible for all charges to their account. Members may charge items purchased at other golf clubs to their Lynx Ridge account providing the other golf club allows reciprocal charging privileges.

# Organizational Information

## **LYNX RIDGE GOLF CLUB**

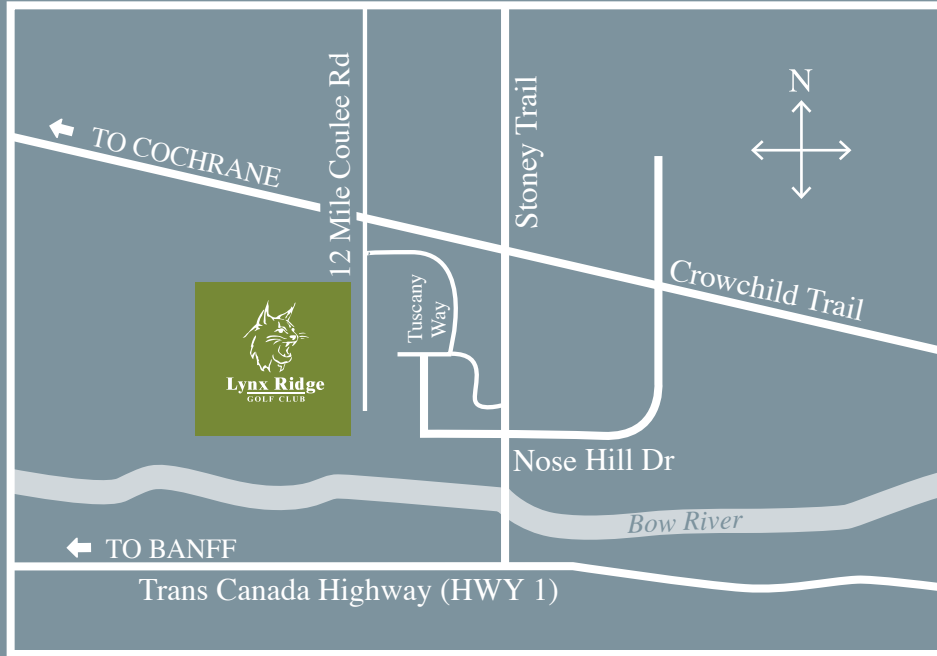
The members are organized into a non-for profit Corporation called the Lynx Ridge Golf Club Society (the Club”). The Club operates with a Board of Directors, which are elected annually by the members. The Club is governed through By-Laws, which are available at the clubhouse for review. The Club will provide each new member with a copy of the By-Laws.

## **MEMBER LEASE OF THE GOLF COURSE**

MGC owns the golf course lands however the Club has obtained a 40-year lease, which provides the members with the right to use the golf course lands. The lease gives the membership a legal interest in the golf course lands and secures the right of the members to use the lands. The lease includes a renewal option after 40 years for an additional 40-year period for an extremely reasonable sum of \$1,000 per membership. The renewal fee is insignificant when considering the value of \$1,000 after 40 years.

## **MANAGEMENT**

The Club has entered into a management agreement with MGC Golf Inc. (the “Manager”) which will operate and manage the affairs of the golf course. MGC Golf Inc. is the nominee corporation for the Lynx Ridge G. C. Joint Venture which is the owner of the golf course. The management agreement also allows the Manager to operate as an agent for the Club in collecting fees and setting and enforcing the policies and rules of the golf course. Copies of both the Lease and the Management Agreement are available for review at the clubhouse.
